**COMMUNITY NEEDS SURVEY**

The Ohio Department of Development (ODD) provides funds to communities throughout Ohio through the Community Development Program. These funds can be used for a variety of activities which primarily benefit low and moderate income residents of the community and may include improvements to infrastructure, public utilities, transportation, housing, public services, ADA modifications, removal of blight, and the upgrade of parks/recreation facilities.

For planning purposes, ODD is requiring Grantees (community recipients of CDBG funds like Wood County) to include information regarding their overall community development need on a prioritized basis. The information you provide will be used to develop a planning framework for current and future project selection and funding. Even if you will not be applying for funding this year, this information will be used to formulate Wood County's CDIS, which is required by the State this year.

If your community is planning on applying for any of the 4 competitive grants, Downtown Revitalization, Neighborhood Revitalization and/or Critical Infrastructure funding, you must inform the county of this intention and provide documentation of need so that it can be incorporated in the county's CDIS. (ODD requires the submission of applications for any of the 4 competitive grant programs to be included in Wood County's Community Development Program application).
