Wood County Planning Commission June 4, 2013 @ 5:30pm

The Wood County Planning Commission met in regular session on Tuesday, June 4, 2013 at the County Office Building in Bowling Green. Planning Commission members in attendance were: Anthony Allion, Rob Black, Jim Carter, Pat Fitzgerald, Doris Herringshaw, Raymond Huber, Richard Kohring, Joel Kuhlman, Donna Schuerman and Leslee Thompson. Planning Commission staff in attendance was David Steiner and Katie Baltz. 18 guests were present at the meeting.

Chairman Thompson called the meeting to order. Upon calling the meeting to order, Mr. Black made a motion to approve the amended April 2013 Planning Commission meeting minutes. Ms. Schuerman seconded the motion and Commission members responded in full support.

Mr. Steiner explained that the May 2013 Meeting minutes had a spelling error that needed corrected. Mr. Kohring made a motion to approve the corrected May 2013 meeting minutes. Mr. Kuhlman seconded the motion and Commission members responded in full support.

FY13 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG)

Mr. Steiner began his review and discussion of this item and reported that a total of 13 applications had been submitted for the FY13 Community Development Block Grant (CDBG) Allocation Program, with a total of \$570,001 being requested. Mr. Steiner stated that \$191,000 was available for funding in FY13, and reported that a total of \$164,260 would be available for up to 4 projects. Mr. Steiner stated that a portion of the funds would be used for the fair housing program and administration of the grant. Mr. Steiner then reviewed the FY13 CDBG applications and briefly detailed the projects that were proposed. They were as follows:

VILLAGE OF BRADNER

Replacement of approximately 750 lineal feet of 6" and 4" water mains on Main Street. Project will include installation of new 8" ductile iron waterline with new valves, hydrants, and individual service lines including meter pits.

VILLAGE OF CUSTAR

Resurfacing of 184 cubic yards of pavement along Superior Street and rehabilitation of 12 sanitary sewer manholes.

VILLAGE OF CYGNET

Resurfacing and repairing 950 feet of pavement on Washington Street.

WOOD COUNTY BOARD OF DEVELOPMENT DISABILITIES

Installation of approximately 225 feet of concrete sidewalk and 2 ADA mats on the southeast corner of Woodlane School to minimize pedestrian traffic in the driveways.

Total Project Cost \$16,178.49 Total CDBG Funds Requested \$16,178.49

Local Contribution \$ 0

After summarizing the details of the applications, Mr. Steiner turned the item over to the Planning Commission members for review and discussion. Ms. Thompson then allowed all individuals who were present in the audience to give a brief summary of their projects.

After much discussion regarding the projects that would be funded, Mr. Black made a motion to recommend to the Board of County Commissioners to fund the following projects, alternates and amounts:

Ms. Schuerman seconded the motion and Commission members responded with a vote of 4 in favor, 4 opposed and 1 abstention (Mr. Carter). Chairman Thompson cast the tie breaking vote in favor of the motion, motion carried.
